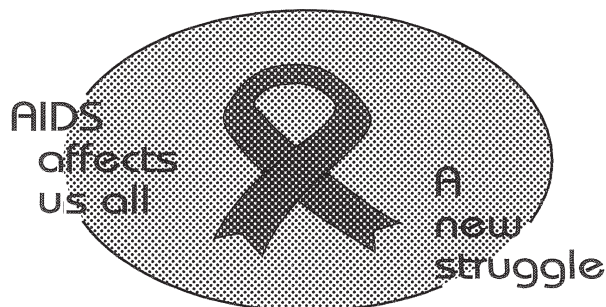

NOTICE IS HEREBY GIVEN that applications for transfer of licence to another person and removal of business to other premises in terms of sections 36 and 37 respectively of the Gambling Act, 1997 (Act No. 5 of 1997) (Eastern Cape) (as amended), particulars of which are set out in the schedules hereunder, have been lodged with the Eastern Cape Gambling Board.

Any objections, petitions or representations shall be lodged with the Chief Executive Officer of the Board within one (1) month of the date of this notice, which commences on **31 August 2020 until 30 September 2020**.

All objections and comments shall specify: the application to which the objection or comment relates; the grounds on which the objection is founded; in the case of comment; full particulars or facts in substantiation thereof: the name, address, telephone and fax number of the objector or person making the comment and a statement whether the objector or person making the comment wishes to make oral representations when the application is heard.

A person lodging representations may show cause why the Board may determine that his or her identity should not be divulged.
